 - d. New working titles: Cloud Print IPP Binding, Cloud Print REST/SOAP Binding, Cloud Multi-Function IPP Binding, Cloud Multi-Function REST/SOAP Binding
 - e. Out of scope items:
 - OOS-1: Defining Cloud federation interfaces and associated protocols and technologies.
 - OOS-2: Defining the interface between the Cloud Imaging Manager and Imaging Device, specifically the interface for device and job status and job submission.
 - OOS-3: Defining new protocols for authentication, authorization, and access control (AAA), discovery, transport, notification, and device management.
 - OOS-4: Defining new document file formats.
 - OOS-5: Defining new job ticket formats.
 - f. Objectives:
 - OBJ-1 Develop a requirements and model document for Cloud Imaging based on the previous BOF discussions.
 - Add registration, discovery/enumeration, selection, etc. from BOF slides
 - OBJ-2 Develop IPP binding documents for Cloud Print and for Cloud Multi-Function services.
 - OBJ-3 Develop REST/SOAP binding documents for Cloud Print and for Cloud Multi-Function services with associated XML schemas/WSDL definitions.
 - Remove "to the extent possible"
 - OBJ-5: Replace "mobile/low-resource" with "consumer-electronics"
 - OBJ-6: Replace "minimum document formats" with "mandatory document formats", "print fidelity" with "imaging fidelity".

and to expand to cover print, fax, scan, etc.
