 - Also print service printing in that case operator does selection, not user

- 6. Mobile device user print using a print provider on the Internet
 - a. Posted to cloud mailing list by Larry Upthegrove
 - b. This is the print service use case we want to add
 - c. Exceptions: Provider quote too high, user selects alternative
 - This is the Select Printer Using Criteria
 - Add charge info text and URI that allow a user to inspect cost structure manually
 - Pull in information from Cloud F2F minutes
 - d. Exceptions: Print operation has issue response returned
 - Exceptions at processing time media not available/compatible
 - Exceptions at print time are for the operator at the print service
 - Cover recipient of notifications in operator and exception use cases
 - e. Exceptions: Purchase denied (card denied, copyrights)
 - Card denied is a billing exception/use case
 - Copyrights are a use case for regulatory compliance
 - "Not picked up"
 - f. Add category of use cases for regulatory compliance
 - Copyright
 - Privacy
 - Identification (not owner or not authorized)
