    - Line 183: Use more formal definition/reference from MFD Model for Client
    - Line 184: Drop "output"
    - Line 185: Use more formal definition/reference from MFD Model for Printer
    - Line 186: Cloud Print Manager (not Printer)
    - Registration: may need to separate client and printer needs further discussion
      - Printers provide services, users provide jobs
      - Is "register" the right verb for users/clients, or something else?
      - Services are registered with access list (everyone or list of users/groups/whatever) and

- owner (a user?)
- Clients provide (and authenticate) identity with Cloud Print Provider, which then allows access to all public services and services for which the user owns or has access to
- Clients only have access to the services in the cloud, not to the printer's services or Cloud Print Manager's services

  - Expand on "hybrid model", e.g. "The cloud can be private, public, or some hybrid federation of the two."
  - "User's location"
- Use cases: fix paragraphs (cut/paste error, lines in paragraphs need to be together to get spacing right...)

  - Make the rest a numbered list
  - Imaging -> Print
  - Imaging Device -> Printer
  - Add out-of-scope for multifunction services and workflows

  - Make subsections a numbered list

- v. Section 4.1: Cloud Print Model Overview
- z. Section 4.1.1 Client:
  - Import definition from IPP; supplies document and print intent to a Cloud Print Provider for a specific print service
  - "Print Client", or just note that this document only deals with print clients?
- a. Global capitalize all terms:
  - client -> Client
  - cloud print provider -> Cloud Print Provider
  - cloud print manager -> Cloud Print Manager
  - printer -> Printer
  - etc.
- b. Additional sections:

  - Section 4.3 Cloud Print Operations (summary/overview)
  - Section 5 Cloud Registration Object (operations and elements/attributes)
