3. Status Reports

Each of the Project Chairs (or appointed spokesperson) provided a brief status of the individual PWG projects.

3.1 Internet Printing Protocol (IPP) Project

Carl-Uno reported that "we're making some progress." The IETF Editor's queue suggests that the IPP documents are close to being published as RFCs—probably within the next month.

The five Notification drafts have been forwarded to the IETF.

The two high priority topics for this week's meeting are Driver Download and the IPP Bakeoff.

3.2 Universal Printer Description File Format (UPDF) Project

No report. Don mentioned that Norbert Schade will issue a statement on the e-mail reflector, stating the progress that has been made on the Font activity.

Don noted that no one has yet volunteered to chair this group, and he is interpreting this as a lack of interest. It is currently expected that the October meeting could be the last one for this group.

3.3 Printer MIB Project (PMP) and Finisher MIB (FIN)

Both the Finisher MIB and Printer MIB updates have been submitted to the IETF for publication. The Finisher MIB is expected to be published as an Informational document, while the Printer MIB is intended to be a Draft Standard.

3.4 1394 PWG

Don Wright reported that the 1394 PWG group should be balloting on the IEEE 1394.3 specification in the next few weeks.

4. LCD Projector

Don announced that the ISTO has purchased a projector device for the PWG meetings. It will be shipped to/from meetings so that none of the attendees will need to carry it on airplanes.
