    - Consensus is to replace 'silicone' with 'water-resistant'
    - Action: Mike to post RFC for laminating-type value 'water-resistant' to IPP list
  - Remaining comments are all editorial, Smith will address in the final published document

  - Need to schedule OAuth 2.0 discussion with Google developers (hopefully July 7 call)
  - Need to also sync up with Microsoft for OAuth 2.0 and Universal Print Service
