 - HP JWE Proposal:
 - Problem we're trying to solve is that printer-uri can have multiple hostnames, but don't know which to use with the AS
 - Also for local printing, X.509 certificates for ".local"
 - hostnames cannot be generated by a traditional CA
 - JWE/JWS token could provide signed identifier that proves it is used with the AS and that printer
 - New value is generated with every query from the Client
 - Work from home printer with OAuth (cloud or local)
 - ACME-IoT one way to provide a local CA
 - Need to identify how to establish trust, how to get resources, etc.
