 - Mike: Historical challenges WRT how to automatically test for conditions other than media-needed (i.e. no easy way to induce low/empty toner/ink, not all printers can sense when a tray is empty without pulling a sheet, etc.)
 - Mike: 2.0 tools will be able to show current states for ad-hoc testing, maybe we can just confirm that all supported states have been tested?
 - Smith: Questionnaire might open a can of worms this way?

- Q: Make tools support for monitoring printer-state-reasons a requirement for 2.0?
 - A: Consensus is yes
- Q: Add a question to the submission form concerning supporting printer-state-reasons?
 - A: Consensus is to think on this some more
 - Q: What about the suffixes (-error, -warning, -report)?
 - Mike: AirPrint/CUPS have long ignored any suffixes, never implemented consistently
 - Ira: Never really widely implemented, probably not worth deprecating
 - Smith: We can defer
