23	Problem Statement:
24	Network print devices have evolved to support additional multifunction services
25	(e.g., Scan, EmailIn, FaxOut, etc.). Such network MFDs are imaging devices that
26	are similar in many ways to network print devices. When network MFDs are
27 28	installed in local office or enterprise networks, there is a need for remote service, device, and job management capabilities so that administrators, operators, and end
20 29	users can monitor their health and status. In addition, there is a need for remote
30	job submission capabilities so that operators and end users can create
31	sophisticated jobs (e.g., with image enhancement, image transformation, etc.)
32 33	without necessarily depending entirely on local console interfaces (which may
33 34	have limited functionality). Currently service, device, and job management and job submission protocols for these network MFDs are fragmented and proprietary.
35	A standard for service, device, and job management and job submission for these
36	network MFDs would benefit both the imaging industry and the user community.

37	
38	NOTE: In Phase 1, the MFD WG will only define the network Scan service, job,
39	and document objects, operations, and attributes (i.e., the definition of the
40	network Scan device object is explicitly out-of-scope in Phase 1).

41 **Out-of-scope:**

- OOS-1. Do not define any compound services (e.g., Scan-To-Email, Scan-To-Fax, or Scan-To-Print).
 OOS-2. Do not define any workflow protocols (i.e., sequencing and coordination
 - of jobs across multiple services).
- OOS-3. Do not define any service management or job operations for MFDs that are not directly network connected.
- 48 OOS-4. Do not define any new document formats to be implemented in network
 49 MFDs (i.e., alternatives to TIFF, JPEG, etc.).

 - (c) defines abstract Scan service, job, and document management objects, operations, and attributes; and
 - (d) defines abstract Scan job submission operation(s) for simple Scan-To-Storage jobs (i.e., scanning one or more physical media pages, performing any required image processing, and storing the results to a local or remote document repository).
- OBJ-5. Define a set of XML Schema files for the abstract Scan service, job, and document objects, operations, and attributes that are defined in the abstract Scan Service Interface specification.
- OBJ-6. Define a Web Services Binding of the abstract Scan Service Interface to one or more public standard Web Services protocols.
